#### 3. Challenges of MSMEs in Arunachal Pradesh

This industry has shown remarkable promise in creating jobs, improving resource use, fostering technological innovation, increasing exports, and decreasing regional imbalances, all while fostering inter-sectoral connections. To this day, however, entrepreneurs continue to confront several obstacles on the path to integration into the MSME sector. As a whole, SMEs account for 45% of India's industrial output, 40% of exports, 60% of the country's employment, 1.3 million annual job creations, and the production of over 8,000 high-quality items for sale in India and throughout the world. The predicted rise in the contribution of SMEs to GDP from 17% in 2011 to 22% in 2012 is substantial. About 12 million people will enter the labor market in the next three years, while there are almost 30 million MSME Units in India.

The eight states that make up India's North East Region (NER)—Arunachal Pradesh, Assam, Meghalaya, Mizoram, Nagaland, Manipur, Tripura, and Sikkim—cover an area of 263179 km², or about 8% of the country's total landmass, and they're all dealing with serious developmental issues. Low capital formation, poor infrastructure, connectivity bottlenecks, geographical isolation, and low per capita income are some of the characteristics of the North East area. A high unemployment rate among the relatively well-educated populace and a general lack of investment in the region's natural and human resource capacities are other hallmarks of this phenomenon. The absence of sufficient and dependable infrastructure is the most significant issue confronting the NER. A sign of the region's industrial backwardness is the manufacturing sector's much lower contribution to the region's state domestic product compared to the country's overall output. The government's various programs and assistance have had very little impact on the economy of the northeast. Neither investors nor entrepreneurs will be interested in it. The private sector has not shown any interest in funding the North East's infrastructure development projects as of now. A number of goals, including the reduction of regional imbalances, the creation of additional job possibilities with less investment, and the stimulation of economic activity, have been assigned to this sector. For a variety of reasons, the MSMEs can't fulfill their function to the fullest. The following are some of the unique challenges encountered by micro, small, and medium-sized enterprises (MSMEs) in Arunachal Pradesh and the rest of the country. These challenges are similar to

- Fewer company units in the area are attributed by policy makers to a lack of entrepreneurial spirit among the population.
- Also vulnerable to marketing issues are these smaller units. Because of this, they are unable to gain first-hand knowledge of the market, including its competitive landscape, customer preferences, likes, and dislikes, and current trends this prevents them from improving their goods in response to customer feedback and market needs. Less of it is of worse quality, and they're charging more for it. Because they can't sell their wares, small and medium-sized enterprises (SMEs) still struggle with marketing.
- One of the biggest challenges faced by small-scale businesses is raising capital. Without sufficient cash, no
  organization can operate properly; hence, finances are the lifeblood of any organization. The main reasons
  for this issue are the lack of available credit facilities and the limited amount of money.
- In order to fulfill their raw material needs, small-scale companies often turn to nearby suppliers. Inadequate quantity, poor quality, and irregular raw material delivery are just a few of the many issues that these units must contend with. All of these things make these units less effective. Raw materials, whether they are locally accessible or imported, may be a huge challenge for small units when it comes to purchasing them. Improper and inconsistent raw material supply is the root cause of the difficulties.

## 4. Growth Prospects of MSMEs

In the Papum Pare district of Arunachal Pradesh, micro, small, and medium enterprises (SMEs) have played a significant role in driving economic growth. In terms of job creation, the MSME industry in Papum Pare ranks second, behind only agriculture. Approximately 60% of the district's industrial units, 35% of its manufacturing output, and 30% of its service sector businesses are accounted for by this sector. When it comes to unleashing faster industrial development, MSMEs have more room to flourish as supplementary industries. Small and medium-sized enterprises (SMEs) benefit from cluster programs in several ways, including better access to raw materials, subsidies, and other incentives, and a lower capital intensity. Utilising existing resources, the Papum Pare offers tremendous expansion possibilities for businesses in the service and industrial industries. As supplementary industries, MSMEs have enormous potential to expand and release even more industrial development. Since it is essential to the District's overall development and contains the key to inclusive progress, the sector's development is of the utmost importance. Arunachal Pradesh has seen a surge in investment in infrastructure, a proliferation of employment possibilities, the establishment of a strong private sector with both small and large enterprises, and a dramatic increase in consumer spending.

With the right policies in place and the right infrastructure in place, the micro, small, and medium enterprise (MSME) sector in Arunachal Pradesh has the potential to become the state's economic backbone and development engine. # a. Businesses Engaged in Production

Manufacturing firms are businesses that make or provide items to other industries. Companies in the manufacturing sector may be further categorised according to their investment in Plants and Machinery (excluding Land and buildings):

- ✓ Micro Enterprises: Put up a maximum of Rs. 25 lakh.
- ✓ Small Enterprises: Investment amounts between 25 lakh and 5 crore rupees are applicable to small businesses.
- ✓ Medium Enterprises: Investments beyond 5 crore and up to 10 crore rupees are considered medium-sized.

## b. Service Enterprises

A service enterprise is a business whose primary activity is the provision of services. Businesses providing services are categorized according to the amount of capital they spend in equipment, excluding land and buildings. For example,

- ✓ Micro companies are described as having an investment of up to Rs. 10 lakh.
- ✓ Investments between 10 lakh and 2 crore rupees for small businesses.
- ✓ Investments in medium-sized businesses beyond 2 crore and up to 5 crore rupees (Govt. of India, 2007: 8-9).

Arunachal Pradesh's businesses are operating in compliance with the MSMED Act, 2006. Medium and small businesses in Arunachal Pradesh have been booming recently. Small and medium-sized businesses in rural regions have benefited substantially from the government-established district industry centers. There was a dramatic growth to 632 micro, small, and medium-sized businesses. Additionally, their investment has been steadily rising. Statistical evidence indicates that investments by MSMEs have risen to Rs. 16,8612.04 lakh. When it comes to the creation of jobs, the MSME sector has also been seeing similar development. The number of people they may potentially hire jumped to 4,491 by the end of March 2020. Additional details are included in the table.

The overall number of businesses in this time period may fluctuate somewhat from what it was in March 2020, since many new businesses have emerged since then. It is quite difficult to disclose the precise number of enterprises in every district in Arunachal Pradesh due to the lack of current statistics. Papum Pare district has the most proportion of permanently registered SSIs (18.53%), while Dibang valley district has the lowest percentage of registered SSIs (just 1 unit), according to the data. The industrialisation process has not yet begun in the newly constituted Anjaw district. When it comes to medium-sized businesses, the Changlang district accounts for 31.25% of the state's total, while the Papumpare district comes in second with 25%. Due to its larger concentration of industry, the Papum Pare region received the lion's share of overall investment (54.17%) from 2012 to 2018. Also, at 32.67%, the Papum Pare area has the greatest employment rate. After excluding the Anjaw district, the Upper Subansiri district has the lowest per-unit employment rate of 1.03%, while the East Siang district has the greatest per-unit employment rate of 26.06%.

## 5. Conclusion

We can conclude that in the micro, small, and medium-sized enterprises (MSMEs) in the research area encounter numerous challenges, such as a lack of timely and sufficient banking financing, inadequate capital and knowledge, outdated infrastructure, inappropriate technology, inadequate production capacity, subpar products, an ineffective marketing strategy, an inadequate marketing department, limitations on modernization and expansion, illness rates, late payments to banks and financial institutions, an absence of affordable skilled labor, inadequate managerial quality, and so on. As a whole and in the area specifically, these issues are hindering the development of the micro, small, and medium enterprise (MSME) sector. The area runs the danger of missing out on the developmental advantages that SSIs might provide unless these structural and peripheral impediments are tackled together. For more inclusive and sustainable industrialisation in the state, targeted strategies are needed. These strategies should prioritise infrastructure upgrading, cluster and value chain integration, improving linkages to external markets, and strengthening local entrepreneurial and institutional capacities. The only way to turn these problems into possibilities for development, employment, and regional harmony is for politicians, business leaders, and entrepreneurs on the ground to work together.
